Section 4. First aid measures

Description of necessary first aid measures

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Spill

Precautions for safe handling

Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not ingest. Avoid release to the environment.
